1. Statistics (Validation of Listing Exercise) Bill, 2021.

5. Resolution to approve the rescission of the Resolution passed in the House of Assembly on the 30<sup>th</sup> day of April, 2019; in the Senate on the 31<sup>st</sup> day of May, 2019; assented to by Her Excellency the Governor-General on the 5<sup>th</sup> day of June, 2019 and published in the *Official Gazette* as Resolution No.11/2019 on the 10<sup>th</sup> day of June, 2019 approving the lease to the Maria Holder Memorial Trust of a parcel of land the property of the Crown situate at Government Hill in the parish of Saint Michael in the Island for the purpose of constructing a nursery school.

6. Resolution in accordance with Section 5 of the *Crown Lands (Vesting and Disposal) Act*, Cap. 225, to approve the lease to the Maria Holder Memorial Trust of the parcel of land the property of the Crown situate at Government Hill in the parish of St. Michael in this Island for the purpose of constructing a nursery school.
